- The total amount of securities reported as indirectly owned by the reporting person represents a reduction of .0666 shares allocated to the reporting person's account in the Company's 401(k) Plan as of July 31, 2013. To manage liquidity needs of the 401(k) Plan, the Plan trustee from time-to-time maintains a lower overall share balance (versus cash) in the 401(k) Plan, which in this instance resulted in a reduction in the number of shares allocated to the reporting person's account when compared to the reporting person's Form 4 filed on July 25, 2013. The information is based on a report dated August 1, 2013, provided by the Plan trustee.
